



## **First Entertainment Credit Union Gift Card Drawing Official Rules:**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MEMBERSHIP NOT REQUIRED. LIMIT ONE PRIZE PER PERSON.

- 1. How to Enter.** During the Promotional Period November 13, 2024 you can enter the drawing by completing an entry form with your name, email address, and survey questions with the representative at the event.

Limit (1) one entry per person. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the Sponsor (aka "First Entertainment Credit Union.") You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of First Entertainment Credit Union.
- 2. Eligibility.** The promotion is open to legal residents of the United States and the State of California as of November 13, 2024. Residents of New York, Florida, Rhode Island and Puerto Rico and other U.S. territories are not eligible for entry. Participants must be eighteen (18) years old or older at the time of the entry. Void where prohibited or restricted by law. Employees, board members, and volunteers of First Entertainment Credit Union are NOT eligible to participate or win a prize. Subject to all applicable federal, state, and local laws and regulations. All eligible entries will be included.
- 3. Drawing and Procedure.** The drawing shall be referred to herein as the "First Entertainment Credit Union Gift Card Drawing." A total of one (1) winner will have been selected at the end of the First Entertainment Gift Card Drawing and receive a \$100 VISA eGift Card. The \$100 VISA eGift Card will be emailed to the winner after compliance with applicable provisions for claiming the prize offering. The drawing will be conducted by First Entertainment Credit Union personnel. The winners will be contacted via the email address provided on the entry form. First Entertainment Credit Union shall have no liability for a winner's failure to receive notices due to winners' spam, junk e-mail or other security settings or for winners' provision of or otherwise non-functioning contact information. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within seven (7) days from the time award notification was sent, or fails to timely return a completed and executed declaration and releases as required, prize may be forfeited, and an alternate winner will be selected. The receipt by winner of the prize offered in this drawing is conditioned upon compliance with any and all federal and state laws and regulations. All decisions of First Entertainment Credit Union are final.

- 4. Prize.** The estimated odds of winning a Visa Gift Card are 1 in 500. The actual odds of winning depend on the number of eligible entries received as of the deadline of the drawing. Prizes may not be transferred or assigned. No prize substitutions will be made. All applicable federal, state and local taxes are the winner's responsibility. Winner will be contacted to arrange delivery at their provided email address.
- 5. General Conditions of Participation.** By participating in the drawing, participant agrees to abide by and be bound by these official rules and the decisions of First Entertainment Credit Union, which are final. By participating, winners releases and agree to hold harmless the Sponsor, including any parents, subsidiaries and all of its respective directors, officers, employees, representatives and agents (the "Released Parties"), from and against any and all liability for any loss, property damage or damage to persons, including, without limitation, death and injury, due in whole or in part, directly or indirectly, arising out of participation in the drawing or use or misuse of any prize. By entering the First Entertainment Credit Union Gift Card Drawing you agree to receive email and telephone communication from First Entertainment Credit Union. You can opt-out of receiving email communication at any time by clicking the unsubscribe link.
- 6. Limitations of Liability.** The Sponsor is not responsible for computer, network, printing, typographical, human or other errors, problems or malfunctions relating to or in connection with the First Entertainment Credit Union Gift Card Drawing, including, without limitation, errors, problems or malfunctions which may occur in connection with the administration of the First Entertainment Credit Union Gift Card Drawing, the announcement of the winner, the processing of entries or in any First Entertainment Credit Union Gift Card Drawing related materials; for stolen, lost, late, misdirected, undelivered, damaged, inaccurate, delayed, incomplete, illegible, or postage-due mail or entries; or for transactions that are lost, misdirected, or fail to enter into the processing system for any reason; or are processed, reported, or transmitted late or incorrectly; or are lost for any reason, including computer, telephonic, paper-transfer, or human error, or electronic, computer, or telephonic malfunction, damage, error, omission, interruption, defect, delay in operation or transmission, or any combination thereof. If, for any reason, the First Entertainment Credit Gift Card Drawing is not capable of running as planned, or infection for computer viruses, bugs, or tampering, unauthorized intervention, fraud, actions of entrants, technical failures, or any other causes corrupt or affect the administration, security, fairness, integrity, or proper conduct of the First Entertainment Credit Union Gift Card Drawing, the Sponsor reserves the right to

disqualify any entry or entrant and/or to cancel, terminate, modify, or suspend the First Entertainment Credit Union Gift Card Drawing and at its sole discretion to disqualify any entry or entrant and/or to cancel, terminate, modify, or suspend the drawing and to award the prize to the selected winners among all eligible non-suspect entries validly received prior to the action requiring such modification.

- 7. Dispute.** Except where prohibited, participant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this First Entertainment Credit Union Gift Card Drawing or any prize awarded shall be resolved individually, without resort to any form of class action; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the First Entertainment Credit Union Gift Card Drawing, but in no event attorneys' fees; and (3) under no circumstances will participant be permitted to obtain awards for, and participant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
